



Delaware School Counselor Association Director Application Packet

*Congratulations on your decision to run for
the Delaware School Counselor Association Board of Directors!*

The term for this position will begin July 1st, 2022. The role of a Director revolves around ensuring the School Counselors in Delaware continue progressing forward as professionals. Directors focus on fulfilling the End Goals of the Delaware School Counselor Association (DSCA). Elected Directors serve a three-year term with the opportunity to run for one additional consecutive term. Only Directors are eligible to serve as *President, Vice President, Secretary* or *Treasurer*.

Eligibility & Application Process

Prospective candidates need to be members of **both ASCA and DSCA**, have at least 3 years of school counseling experience and currently hold a position as a School Counselor in the state of Delaware. Candidates who meet these requirements are eligible to run for the Board of Directors.

To apply, please submit the following:

- *a Candidate Statement of 250 words indicating why you are seeking election*
- *a color photograph (jpeg format)*
- *a professional resume.*
- *a completed Professional Endorsement form (included in this packet) signed by your supervisor*

What happens next?

- Candidates are not permitted to campaign or solicit votes prior to or the day of voting. Candidates who violate this policy will be removed from the ballot. By submitting the above information, you are agreeing to this policy.
- Your statement, photograph and resume will be posted on the DSCA website and viewable by voting members.
- Voting members will cast their votes electronically during the 2022 Winter Conference. Votes will be tallied and the winner will be announced virtually after the conclusion of the Winter Conference.
